FY 16 Budget and Communication Update

June 2015

CEO Update, Jon Clontz

On Monday, June 15, 2015, the Board of Directors approved Lottery's, FY16 budget. Enclosed is the budget for your review. If you have any questions regarding this budget, please do not hesitate to contact my office.

As you will notice, we are currently projecting a year-end net income of \$200,000. Should the lottery accomplish \$27,000,000 in revenues, the net income amount may be transferred to the state.

Our total approved budget for FY15 was \$6.9 million and our total approved budget for FY16 is \$5.8 million. This is a notable decrease of \$1.1 million and includes our loan payoff by fiscal year-end. The payoff of the loan will establish a benchmark of revenue transfers for years to come.

Updates

To-date we have 441 retailers. In FY15, retailers garnered \$1,078,367.29 in lottery revenues.

Lottery continues to conduct product research in an effort to determine the next games that will be added to the Lottery's game portfolio. At this time, we do not expect to add any new games until the loan is paid in full.
