

WyoLotto[®] 2by2[®] Retailer Incentive Program

Terms & Conditions

Introduction: Wyoming Lottery will be conducting a Retailer Incentive program. This contest is for eligible retail locations in the State of Wyoming that sell Wyoming Lottery products. The contest will give retailers the opportunity to win \$1,000 based on the percentage increase of 2by2 sales.

Privacy Statement

To register and participate in the WyoLotto 2by2 Retailer Incentive, you must provide some personal information such as your name, ZIP code, email address and telephone number so that Wyoming Lottery Corporation (WyoLotto) can contact you. If you win a prize, you will be required to complete a W2G and any other forms required for tax reporting purposes, and we will collect your birth date, social security number, name, address, etc. WyoLotto will keep this information confidential and in January 2022, you will receive a 1099 for tax reporting. We will only disclose your personal information if ordered by a court or the Attorney General, or if otherwise required by law.

As our winner, you are agreeing to allow WyoLotto and its Marketing Agency, Warehouse Twenty One, to use your name and the city where you live in a WyoLotto promotional campaign, announcements, advertisements or press releases.

OVERVIEW

These Terms and Conditions are to safeguard that the winner selection process is conducted in accordance with procedures and rules to assure complete integrity, fairness, honesty and security of the winner selection process.

Definitions

- A “sales clerk” is defined as a manager or other WyoLotto retailer employee that sells WyoLotto tickets.
- A retail location is a current Wyoming Lottery retailer that sells Wyoming Lottery products

Entry

- 1) The top ten retail locations to have the highest percentage of increase of 2by2 ticket sales for the incentive weeks outlined below will automatically be entered into the giveaway.
- 2) Before this giveaway begins, WyoLotto will establish a baseline of sales for all retailer locations for the first week of 2by2 sales running March 14, 2021 - March 20, 2021. For any retail location that was not an official WyoLotto retailer during the timeframe of March 14, 2021 - March 20, 2021, they will not be eligible for this incentive program.
- 3) After the first week (March 14, 2021 - March 20, 2021) of 2by2 sales, WyoLotto will review each retail location sales for the next three weeks and determine top performing retail location by percentage of increase from the previous week’s sales. Each week’s sales that will be eligible are: March 21, 2021 - March 27, 2021; March 28, 2021 - April 3, 2021; and April 4, 2021 - April 10, 2021.
- 4) The sales clerks from the top ten retail locations with the highest percentage growth of 2by2 sales will be entered into the giveaway, based on names provided by each retail location. If any two retail locations are tied, both stores will be entered to win.
- 5) Intralot will work directly with those top performing stores to compile names from those retail locations that worked during the giveaway time period. All eligible names will be entered into the contest and randomly selected to win one of the prizes.
- 6) Agree to the terms and conditions of giveaway.
 - a. If an entrant does not ‘agree’ to the terms and the conditions of the giveaway by signing below, they are forfeiting their entry.

Once the above steps are completed, this will be recorded as an entry.

Prize Details

Prize - Week 1, March 21, 2021 - March 27, 2021

- One winner will receive \$1,000 cash
- Entry Period - The entry period extends from March 21, 2021 - March 27, 2021.
- Drawing Date - The drawing will be held on April 15, 2021. The winner will be selected at random.

Prize - Week 2, March 28, 2021 - April 3, 2021

- One winner will receive \$1,000 cash
- Entry Period - The entry period extends from March 28, 2021 - April 3, 2021.
- Drawing Date - The drawing will be held on April 15, 2021. The winner will be selected at random.

Prize - Week 3, April 4, 2021 - April 10, 2021

- One winner will receive \$1,000 cash
- Entry Period - The entry period extends from April 4, 2021 - April 10, 2021.
- Drawing Date - The drawing will be held on April 15, 2021. The winner will be selected at random.

Announcement Date

Winners for all three prizes will be announced publicly on April 19, 2021 or as near to the drawing date as deemed possible.

I. CONTEST

- A. WyoLotto will use commercially reasonable efforts to ensure the prize(s) awarded in this promotion is determined as impartially and randomly as practical.
- B. WyoLotto will use commercially reasonable efforts to ensure the integrity of the Lottery is maintained.
- C. WyoLotto will use commercially reasonable efforts to ensure the drawing or winners selected is conducted in strict compliance with Terms and Conditions.
- D. WyoLotto will use commercially reasonable efforts to ensure compliance to all applicable statutes, rules and regulations.

II. ELIGIBILITY

- A. You must be at least 18 years of age or older to enter.
- B. You must be an individual and reside in Wyoming to enter.
- C. You must be an employee of a current retailer of a WyoLotto store at the time of this contest to enter.
- D. WyoLotto CEO or designee will make all final decisions regarding the eligibility of entries and/or participants.
- E. If it is determined by WyoLotto that you stole data from or are associated with attacking, infecting, or intruding upon any computer system owned by or associated with WyoLotto or which in any way

threatens the security of WyoLotto's computer system, WyoLotto may immediately disqualify any portion of or the entire list of entries. WyoLotto reserves the right to seek damages to the fullest extent permitted by law and may seek criminal charges.

- F. If WyoLotto determines an entry to be valid, and the entry was not entered into the drawing due to WyoLotto or database error, as determined by WyoLotto CEO or designee, that entry can be entered into a comparable drawing for a prize of like value, or an alternate prize may be offered at a future time to be determined by WyoLotto CEO or designee. WyoLotto CEO or designee's decision is final.
- G. Should conduct by a retailer be determined as unethical by the WyoLotto CEO or designee, any entries associated with that retailer may be disqualified from the contest.

III. DRAWING DETAILS

- A. Winners will be drawn by random from all eligible entries submitted.
- B. For each week of prizes, one prize winner will be selected randomly from all eligible entries for each week. Three (3) alternate prize winners will be selected randomly from all eligible entries. In the event the first prize winner drawn does not accept their prize and/or agree to the terms set forth or cannot be contacted, one alternate winner will be contacted in the order selected and the winner must agree to the terms. If not, the next alternate will be contacted, and so on until a winner is defined.
- C. Odds of winning are dependent on the total number of eligible entries received during the entry period.
- D. Drawing Date - The drawing will be held on April 15, 2021. The winner will be selected at random.

IV. NOTIFICATION OF WINNER

- A. Winners will be notified on April 15, 2021 by 5:00 p.m. MDT via phone, text, and/or email. Winners must respond by 9:00 a.m. on April 16, 2021.
- B. Winners must verbally accept the terms of their prize by 12:00 p.m. on April 16, 2021 or the next alternate winner will be contacted.
- C. WyoLotto and Intralot will make reasonable attempts to notify the winner via phone, text and/or email.

V. PRIZE CLAIM RULES

- A. Prizes are not transferable from the winner to any other individuals.
- B. Winners must fill out a Wyoming Lottery Prize Claim form.

VI. PRIZE TAXES, FEES & EXPENSES

- A. Disclosure Requirement: To receive a prize the winner shall furnish to WyoLotto the information required on the Internal Revenue Service Form W2G (or any other form required by the IRS), including but not limited to, the winner's name, address and social security number. This disclosure is mandatory and the authority for such disclosure is 42 USC 405 (c) (2) (C); 26 CFR 31.3402 (q)-1 (e). A winner's social security number will be used for the purpose of submitting required documents to federal tax authorities.
- B. The prize winner is responsible for all applicable taxes, liens, or other legal or governmental charges.

VII. DISCLAIMER

- A. Employees or representatives of the WyoLotto advertising agencies, their spouses, children or any relatives residing in the same household as the employee or agent are ineligible to participate. You agree that you will hold harmless and indemnify WyoLotto and its agents from and against any damages based on your participation in this promotion.
- B. By accepting the prizes discussed herein, the winners agree to accept any prizes "as-is" with no representations or warranties on the condition of any such prize.
- C. Winners must verify they are a Wyoming resident at the time of the drawing. For purposes defined as an individual who maintains permanent residency within the State of Wyoming at the time of the drawing. Winners will be required to provide two forms of proof of residency sufficient to demonstrate residency.
- D. WyoLotto shall not be required to release prizes to any winners until such time as WyoLotto has completed any necessary security, tax, legal or other reviews.
