Establish Quorum:

Chairwoman Gina Monk called the meeting to order at 8:30 a.m. with a roll call of board members and staff members.

Agenda Approval:

Chairwoman Monk presented there were no additions or changes requested to the agenda.

Approval of the Minutes:

Minutes from August 7, 2023

Chairwoman Monk wanted to add "in Cheyenne" to Page 5 regarding the launch of the ticket dispenser machines and "in all areas of the state".

Vice Chairman Todd Peterson questioned Mr. Jon Clontz regarding the question made by Jim Willox in the August 7th board meeting about different Jackpot payouts. Mr. Clontz stated that he did bring it up to Bret Tyron and it was shelved until the upcoming NASPL meeting in Wisconsin. Mr. Clontz will follow up with Bret in Wisconsin.

Following a Motion from Jim Willox and seconded by Board Treasurer Gerry Marburger, the minutes were approved by a unanimous vote.

CEO Report:

Wyoming Lottery Corporation (WLC) CEO Jon Clontz reported and discussed the following:

- NASPL annual conference coming up in Wisconsin that Chairwoman Monk and Vice Chairman Peterson will be attending
 - The CEO of Intralot will meet Chairwoman Monk and Vice Chairman Peterson
- New Game Research
 - Mr. Clontz will share his findings, the details, and numbers at the January board meeting
 - Cash Pop is an interesting new game that we will be looking into further (Florida, Michigan and Mississippi have this game)
 - Simple basic game
 - Good fit for Wyoming
 - 1-15 numbers and you can bet up to 5 times on a certain number or several numbers
 - 1 or 2 draws a day / 7 days a week
 - Intralot is on board however, they are wanting to do a presentation regarding their Pitch Perfect game
 - We could bolster revenue with this new game to make up for the loss of 2by2 revenue or get rid of 2by2 all together
 - Ticket Dispensers
 - Robin will be updating the Board on the machines with her presentation later on with her marketing presentation
 - WLC Audit
 - Great outcome and grateful for Brandy and her team and MH&P
 - o BOGO
 - Has been producing great revenue and we are excited to get to do it every time the Pokes win.
 - Legislative Session
 - Teaming up with Jessie Dafoe to get prepared for the upcoming session and the strategic plan.

Budget:

Brandy Marrou from MH&P presented the FY'22 Audit.

- No significant issues in performing this audit
- Audit went very well, and everything MH&P needed to perform the audit was received on time
- No significant or usual transactions
- MH&P proposed 4 audit adjustments
 - 3 of those adjustments relate to the standards
 - The pension liability
 - The lease asset and liability
 - The subscription asset and liability

- These adjustments are what the lottery has asked MH&P to be prepared on their behalf and Mrs. Loy Jackson reviews and approves them
- The 4th audit adjustment that was proposed
 - Cleaning up the lottery's fixed assets
 - Several assets no longer being used in operation
 - Eliminated the cost and accumulated depreciation
 - No impact to net income as a result of that adjustment
- General Observations
 - No disagreements with management
 - Not aware of any areas where management consulted with other accountants over areas that were disagreed with
 - No significant issues discussed with management related to the audit other than the implementation of these new standards
- No difficulties or issues that need to be brough to the Board's attention

Mrs. Jackson presented an overview of the Financials. All directors had received detailed statements prior to the board meeting. Statements are attached.

Questions from Board Members:

- 1. Who has WLC credit cards and do they get paid every month?
 - **a.** Yes, the credit cards get paid every month and Jon Clontz, Robin Medina, Loy Jackson, Dave Stevens, Marty Baker and Jessica Baldwin have credit cards

2. Transfers to the State

a. Mrs. Jackson and Mr. Clontz will be working with the State Treasurer to change the date of the transfer to give Mrs. Jackson more breathing room to calculate expenses for the lottery. Normally, the transfer to the State happens on the 5th however, they will be contacting the Treasurer to discuss a new potential transfer date of the 15th.

3. Can reserve funds be moved into the building fund?

a. Brandy with MH&P stated there is no restrictions when it comes to the reserve fund and it is fully at the Board's discretion to move those funds

Board Secretary Dave Snyder made a motion to approve the financials as presented. The motion was seconded by Board Member Willox, and the motion passed by a unanimous vote.
