

WyoLotto[®] Cowboy Draw[®] “BOGO” Promotion Terms & Conditions

Privacy Statement

- A. To participate in the Wyoming Lottery Corporation (“WyoLotto”) Cowboy Draw BOGO Promotion, you must be 18 years of age or older. If you win a game prize, you will be required to complete a W2G form (and any other forms deemed to be required by WyoLotto) for tax reporting purposes. Additionally, WyoLotto may at any time require receipt of any winner’s birth date, social security number, full legal name, address, and any other information deemed necessary in the sole discretion of WyoLotto. WyoLotto will keep this information confidential, and will only use such information for necessary reporting and/or compliance purposes, or if required to disclose by a government authority or court order. Upon claiming your prize, you will receive a 1099 for tax reporting, however, individual tax reporting is the sole responsibility of winners.
- B. As a winner of any Cowboy Draw prize-tiers, you will have the choice to share your identity, or choose to remain anonymous, through a publicity form WyoLotto will provide to you at the time of claiming your prize. WyoLotto will not publicly identify you without your consent.
- C. As a winner of the \$20,000 prize, you are agreeing to allow WyoLotto and its Marketing Agency, Warehouse Twenty One, to use your name, photo, and the city where you live in a WyoLotto promotional campaign, announcements, advertisements, and press releases. Upon claiming your prize, WyoLotto will withhold the required amount by the Internal Revenue Service and you will receive a 1099 for tax reporting, which is the sole responsibility of the winner.

Overview

The purpose of these terms and conditions is to ensure that the promotion and any associated process is conducted in accordance with these procedures and rules, in compliance with

applicable laws, and to assure complete integrity, fairness, honesty and security of WyoLotto's ticket claim process.

Entry

To enter to win this giveaway, you must:

- Purchase a WyoLotto ticket for Cowboy Draw during the period of a buy-one-get-one free promotion, which occurs between 11 a.m. and 2 p.m. Mountain time, the Sunday after the University of Wyoming Football team wins a game during the 2024 season.
- Upon purchasing a ticket during the promotional period, you will receive a free ticket with a code printed on it. You must enter that code on the website:

 - One entry per person, per code after each University of Wyoming Football win, with a chance of up to 12 (twelve) entries per person. Number of entries will vary based on the number of participants and number of games the University of Wyoming Football team wins.

Prizes

Promotional Period

Dates may be subject to change if the football schedule changes. WyoLotto reserves the right to add or remove dates at any time.

All eligible entries must be submitted to wyolotto.com/bonusdraw no later than December 5, 2024 at 12 p.m. MT.

Winner Selection

One prize winner will be drawn using a random digital drawing no later than December 6, 2024 at 12 p.m. MT. The winner will be selected through a random selection process and verified. The drawing will be held at Wyoming Lottery Corporation Headquarters: 1620 Central Ave., Ste. 100, Cheyenne, WY 82001. The winner will be contacted immediately to verify submission and will be required to follow our winner claim process to receive their winnings.

Announcement Date

Prize winner will be announced via social media and email no later than December 13, 2024.

I. CONTEST

- A. WyoLotto will provide its best effort to ensure the prize(s) awarded in this promotion are determined as impartially and randomly as practical.
- B. WyoLotto will provide its best effort to ensure the integrity of the Lottery is maintained.

- C. WyoLotto will provide its best effort to ensure the drawing or winners selected is conducted in strict compliance with Terms and Conditions.
- D. WyoLotto will provide its best effort to ensure compliance to all applicable statutes, rules and regulations.

II. ELIGIBILITY

- A. You must be at least 18 years of age or older to purchase a ticket and to participate. If WyoLotto determines a purchase to be valid, and the player did not receive a free ticket due to WyoLotto error, as determined by the WyoLotto CEO (or his designee), that player may be given a free play of equal value, or an alternate prize may be offered at a future time to be determined by the WyoLotto CEO or designee. The WyoLotto CEO or designee's decision is final.
- B. This promotion shall be governed by the Wyoming Lottery Act, and any and all other applicable laws, rules, and regulations.
- C. If WyoLotto determines an entry to be valid, and the entry was not entered into the drawing due to WyoLotto error, as determined by the WyoLotto CEO (or his designee), that entry can be entered into a comparable drawing for a prize of like value, or an alternate prize may be offered at a future time to be determined by the Lottery CEO or designee. The Lottery CEO or designee's decision is final.

III. DRAWING DETAILS

- A. One winner will be selected from all valid entries through the website wyolotto.com/bonusdraw.
- B. One prize winner will be selected at random from all eligible entries and recorded according to WyoLotto security protocol. In the event any prize winner drawn does not accept their prize and agrees to the terms set forth or cannot be contacted within one business day, one alternate winner will be contacted in the order selected and the

winner must agree to the terms. If not, the next alternate will be contacted, and so on until a winner is defined.

- C. Odds of winning are dependent on the total number of eligible entries received during the entry period.

IV. PRIZE CLAIM RULES

- A. Any prize won pursuant to this promotion is not transferable from the winner to any other individuals.

V. PRIZE TAXES, FEES & EXPENSES

- A. To receive a prize the winner shall furnish to WyoLotto all the information required on the Internal Revenue Service Form W2G (or any other form required by the IRS), including but not limited to, the winner's name, address and social security number or Tax ID number. This disclosure is mandatory and the authority for such disclosure is 42 USC 405 (c) (2) (C); 26 CFR 31.3402 (q)-1 (e). A winner's social security number or Tax ID number will be used for the purpose of submitting required documents to federal tax authorities.
- B. The prize winner is responsible for all applicable taxes, liens, or other legal or governmental charges.
