Terms & Conditions

Privacy Statement

To participate in the WyoLotto NASCAR Powerball Promotion, you must provide personal information such as your name, ZIP code, email address and telephone number so that Wyoming Lottery Corporation (WyoLotto) can contact you. If you win a prize, you will be required to complete paperwork similar to WyoLotto claim procedures. WyoLotto will keep all personal information confidential, unless you are a winner. We will only disclose your personal information if ordered by a court or the Attorney General, or if otherwise required by law.

As a winner, you are agreeing to allow WyoLotto and the Marketing Agency, Warehouse Twenty One, to use your name, photo, and the city where you live in a WyoLotto promotional campaign, announcements, advertisements, and press releases.

OVERVIEW

These terms and conditions are to ensure that the process is conducted in accordance with procedures and rules to assure complete integrity, fairness, honesty and security of the winner selection process.

Entry

 - Each code may be entered one time per person for a chance to enter up to 14 codes total during the promotion.

Prizes

- Five (5) winners will be entered into the [NASCAR Powerball Playoff](#) national drawing.
 - One (1) winner from these five (5) winners will be randomly selected to go to the NASCAR Championship Weekend from Oct. 31, 2025 to Nov. 3, 2025, provided in partnership with Powerball. If any of the five (5) winners is drawn as a finalist in the final four (4) of the NASCAR Powerball Playoff national drawing, that winner will be eliminated from the WyoLotto drawing for the NASCAR Championship Weekend package, and the drawing will be randomly selected from the remaining winners.

The package includes:

<i>Airfare</i>	Roundtrip flights for two (2) passengers from closest primary airport to Phoenix, AZ (PHX Sky Harbor).
<i>Hotel</i>	Three (3) nights for two (2) persons, double occupancy.

Entry Period

The entry period extends from May 1, 2025 to June 2, 2025 at 11:59 p.m. MT. All entries must be received by WyoLotto by 11:59 p.m. MT June 2, 2025 through the entry method listed in the Entry section of these Terms and Conditions. Any entry received after June 2, 2025 will not be eligible.

Winner Selection

Five (5) winners to be entered into the NASCAR Powerball Playoff will be drawn no later than June 11, 2025. The winners will be selected through a random selection. The drawing will be held at Wyoming Lottery Corporation Headquarters: 808 W 20th St., Cheyenne, WY 82001. The winners will be contacted immediately to verify submission.

If any of the five (5) winners is drawn as a finalist in the final four (4) of the NASCAR Powerball Playoff national drawing, that winner will be eliminated from the WyoLotto drawing for the NASCAR Championship Weekend package.

If none of the five (5) winners are selected in the national drawing as a finalist in the final four (4), then from the five (5) winners, one winner will be randomly selected on or before Oct. 9, 2025 for the NASCAR Championship Weekend trip. The winner will be selected through a random selection. The drawing will be held at Wyoming Lottery Corporation Headquarters: 808 W 20th St., Cheyenne, WY 82001. The winner will be contacted immediately to verify submission.

Announcement Date

The five (5) prize winners for the NASCAR Powerball Playoff will be announced by WyoLotto no later than June 23, 2025. The prize winners must agree to be able to travel to Phoenix, AZ for the NASCAR Championship Weekend (Oct. 31, 2025 to Nov. 3, 2025).

One winner from these five (5) winners will be announced by WyoLotto no later than Oct. 15, 2025 for the trip to the NASCAR Championship Weekend package.

I. CONTEST

- A. WyoLotto will provide its best effort to ensure the prize(s) awarded in this promotion is determined as impartially and randomly as practical.
- B. WyoLotto will provide its best effort to ensure the integrity of WyoLotto is maintained.
- C. WyoLotto will provide its best effort to ensure the drawing or winners selected is conducted in strict compliance with Terms and Conditions.
- D. WyoLotto will provide its best effort to ensure compliance to all applicable statutes, rules and regulations.

II. ELIGIBILITY

- A. You must be at least 18 years of age or older to enter and to win.
- B. You must be able to supply a Tax ID Number or Social Security Number and appropriate identification to claim a prize.
- C. By entering your ticket(s), you are agreeing to the terms of the giveaway.
- D. The WyoLotto CEO or designee will make all final decisions regarding the eligibility of entries and/or participants.
- E. If WyoLotto determines an entry to be valid, and the entry was not entered into the drawing due WyoLotto error, as determined by the WyoLotto CEO or designee, that entry can be entered into a comparable drawing for a prize of like value, or an alternate prize may be offered at a future time to be determined by the WyoLotto CEO or designee. The WyoLotto CEO or designee's decision is final.

III. DRAWING DETAILS

- A. All winners will be selected from all valid entries according to the Entry section set herein.
- B. Five (5) winners will be selected at random from all eligible entries via a random selection drawing and recorded according to WyoLotto security protocol to be entered into the NASCAR Powerball Playoff national drawing. If any of the five (5) winners is drawn as a finalist in the final four (4) of the NASCAR Powerball Playoff, that winner will be eliminated from the drawing for the NASCAR Championship Weekend package.
 - a. One (1) prize winner will be selected at random from the five (5) winners via a random selection drawing and recorded according to WyoLotto security protocol to win the NASCAR Championship Weekend package.
- C. In the event any prize winner drawn does not accept their prize and agrees to the terms set forth or cannot be contacted, one alternate winner will be contacted in the order selected and the winner must agree to the terms. If not, the next alternate will be contacted, and so on until winners are defined.

- D. Odds of winning are dependent on the total number of eligible entries received during the entry period.

IV. NOTIFICATION OF WINNERS

- A. The five (5) winners for the NASCAR Powerball Playoff will be notified no later than June 3, 2025 via phone or email.
 - a. The five winners must verbally accept the terms of their prize by 5:00 p.m. June 6, 2025, or the next alternate winner will be contacted.
- B. The one (1) winner for the NASCAR Championship Weekend package will be notified no later than Oct. 10, 2025 via phone or email.
 - a. The winner must verbally accept the terms of their prize by 5:00 p.m. Oct. 13, 2025, or the next alternate winner will be contacted.
- C. WyoLotto will attempt to notify the winners via phone, text or email.

V. PRIZE CLAIM RULES

VI. PRIZE TAXES, FEES & EXPENSES

- A. A winner's social security number will be used for the purpose of submitting required documents to federal tax authorities.
